### Wini Roche County Council District F 2018

#### 1. What improvements are needed for your district?

I intend to put a major focus on the redevelopment and revitalization of Rt. 40 and would like to explore attracting a full service conference center to District F. I have a major interest in the relocation plans of Harford Memorial Hospital and ensuring the delivery of health care is not only sustained but improved in district F- especially in the area of mental health where resources are limited. I will work to improve the Rt. 40 Corridor and promote the redevelopment of this neglected area of the County.
